One of the characteristics of library research is that researchers deal directly with texts (nash) or numerical data and not direct knowledge from the field or eye-sight in the form of events, people or other objects. (Zuhri Abdussamad, 2021) The study used in compiling the linguistic aspects of textbooks is a literature study. For literature that is used as a reference as a guideline in the form of books, theses, and journals that are recognized by national standards, then studied and used as a guideline to study aspects of linguistic analysis in the ability to motivate students. The approach used in this study is a qualitative approach, namely an approach that produces descriptive data in the form of written words from people being observed that are not expressed in terms used in quantitative research. The technique used in this article research is in the form of documentation by taking and collecting information materials in the form of writings including books, journals, articles (Hikmawati, 2020).

New student orientation is an activity carried out for the acceptance of new students by introducing the situation and conditions that exist in the school educational institution. The purpose of new student orientation is so that each student can understand and obey all regulations that apply at school (Saifurrahman, 2016). That way, students are ready to face a new environment, both physically, mentally and emotionally, so that students can feel at home in following the learning process and can actively participate in every activity held at school.

7. Regulating student level increases

Class increases can be regulated according to the policies of each school. In class increases, problems often occur that require wise resolution. This problem can be minimized if data on student evaluation results are assessed objectively and use the functions as they should, teachers must also be more careful in giving evaluation results to their students (Imron, 2012).

8. Student coaching and development

The purpose of student coaching and development is to foster and assist in developing the potential possessed by students in various types of learning. Success in student coaching and development can be measured through assessments carried out by teachers based on the assessment principles applied in schools. The assessment measures used are in the form of moving up a class or not moving up a class, passing or failing students at the final level of study (Ramadhan & Sufia, 2023)

Coaching is carried out by providing direction to students regarding what tasks must be done while studying at the school. The principal must create a program to improve student abilities. To improve student abilities, the principal is required to manage student planning, conduct coaching and evaluate student activities. (Trisnawati et al., 2022)

In addition to student development and coaching which is reviewed from a co-curricular perspective, there are also extracurricular activities. Extracurricular activities are activities carried out outside of class hours, either carried out at school or outside of school but still

The following verses are the basis for Islamic educational management. One of them is in the Al-Qur'an surah At-Taubah: 122 which reads:

Meaning: "It is not appropriate for all believers to go (to the battlefield). why do not some people go out from each group among them to deepen their knowledge of religion and to warn their people when they have returned to it, so that they may guard themselves (QS. At-Taubah: 122)."

In this holy verse there is an explanation of an important rule in the Qur'an, namely that believers should not all go to the battlefield or all go to seek knowledge, just as it is not allowed to excel. Therefore, it is better for each group to have one group that seeks knowledge and deepens religious knowledge, and then returns to provide guidance to its people (Daryono et., 2021).

Islamic education management is a system that processes the management of Islamic educational institutions in an Islamic manner according to clear sources. According to language, management comes from the word idaarah, which comes from the word adaara, which means to regulate. Ramayulis (2013), stated a similar meaning to the essence that management is al-Tadbir which means regulator and the origin of the word is dabbara which means regulating many things. This is found in the letter as-Sajdah: 5 which reads:

يُدَبِّرُ الْأَمْرَ مِنَ السَّمَآءِ اِلَى الْأَرْضِ ثُمَّ يَعْرُجُ اِلَيْهِ فِيْ يَوْمِ كَانَ مِقْدَارُهُ الْف سنَبَّةِ مِمَّا تَعُدُّونَ

Meaning: He regulates all affairs from the heavens to the earth, then (all affairs) ascend to Him) on a day whose measure (duration) is a thousand years according to your reckoning.

From the verse there is the word dabbaru which is to regulate/manager the Regulator of this universe. Because humans were created by Allah SWT as caliphs on earth, humans must regulate and manage the earth well according to His teachings. Thus the meaning of Islamic education management is the process of utilizing existing resources, the utilization of resources is carried out in collaboration with others effectively, efficiently and productively in order to achieve the goals of happiness and well-being both in the world and in the hereafter. One of the important components of Islamic education management is student management. Students are individuals who are growing and developing and need lifelong guidance and direction through the person who gives (educator). Students are not only children, adults can also be said to be students seeing the situation and conditions. In religion it is explained that children are born in a state of fitrah (pure) but parents or the environment that makes the child do good or do bad. The environment can be said to be educational institutions (formal), family (informal) and society (non-formal).

Meaning: "Seeking knowledge is an obligation for every Muslim." This hadith requires everyone, both men and women, although this hadith does not state that Muslim women are Muslim, it already includes women. Students are children and adults who are growing and developing who expect guidance and direction from people who have knowledge about education. Students are the ones who determine the fate of this country, the progress or decline of the country lies in the hands of the students, so the task of an educator is to direct and guide them in a learning process that does not run away from the goals of education. (Ahmad, 2012)

From the description, it can be concluded that students are learners or individuals who grow and develop and expect knowledge, guidance, direction from educators so that students have a spiritual, social attitude, knowledge and skills so that students become independent children, useful for religion, country, nation and state.
