This study aim to determine the types of declarative speech act found in Hansel and Gretel: Witch Hunter movie, and also to find the dominant types of declarative speech act in the movie. Qualitative research is defined as a research method that focuses on obtaining data through open-ended and conversational communication. Qualitative research is a means for exploring and understanding the meaning individuals or group ascribe to a social human problem (Creswell: 2012) There are 4 types of declarative speech acts found in the movie. That is consisting in declarative speech act namely Command, Order, Request, and Suggestion. The most dominant type of declarative speech act used is Command. There were 48 declarative data taken from transcript Hansel and Gretel: Witch Hunter Movie. It consisted of 23 (48%) for Command, 10 (21%) for Order, 5 (10,41%) for Request, and 10 (21%) for Suggestion. The most dominant declarative speech acts in this transcript was Command with the total amount 23 (48%). The writer concludes that the most dominant declarative acts in the movie is command, which means that the characters in the story prefer everything to run quickly, command is a declarative speech act message that wants the recipient of the message to be able to immediately do what the speaker says. the study of meaning which is related to the speech situations. In line with this, Richard and Schmidt (2013) argue that pragmatics is the study of the use of language in communication related to sentences and the context and situations in which they are used.

Behind an utterance there is a language function that is reflected in the meaning of the utterance. Every speech event is limited to activities, aspects of activities that are directly regulated by rules or norms for speakers.

As such, it has more to do with analyzing what people mean through their speech than it does with analyzing what words or phrases mean in the speech itself. ## **Illocutionary Act**

Illocutionary speech acts are utterances that function to say or inform something, besides that it can also be used to do something. Speech acts are divided into five parts according to Searle in Levinson (1983: 240) which states that the division is representative, directive, commissive, expressive, and declarative. This illocutionary speech act can be identified if it has previously been considered who the speaker and the interlocutor are, when and where the speech act occurs. Illocutionary speech acts are a central part of understanding speech acts.

## **Declarative Speech Act**

Declarative is Kinds of speech act that change the world via their utterance. In using a declaration, the speaker changes the world via words. Declarative are also speech acts whose utterances cause instantaneous changes in the institutional environment and often depend on complex foreign language institutions. These speech acts include excommunication, declaration of war, baptism, and dismissal.

For example "you are dead to me".

(the speaker attempts to declare that someone has died for him or it can be said he doesn't know that person anymore)

According to Yule (1996), declaration are those kinds of speech acts that change the world via utterance. The illocutionary aspect of these is that they are attempts (of varied degrees, and thus more accurately, determinates of the determinable which includes attempting) by the speaker to get the listener to do something. Searle (1979) classified directive speech act into commanding, requesting, advising, and warning. Commanding is the utterance that gives an instruction and the hearer will do something based on the instruction. Some steps in gathering the data to be studied in this chapter. The following are some steps to gathering the data and analyzing the data:

- 1. Downloaded the Movie
- 2. Watched the film several times
- 3. Transcribed the script of the data based on English subtitles.
- 4. Make a list of utterances consisting of speech acts
- 5. The writer analyze and classifyed the data into types of speech acts according to Yule's theory.
- 6. The writer investigate the function of speech acts according to Yule's theory. Based on the first research question, the writer will use three main types of speech acts namely locutionary acts, illocutionary acts, and perlocutionary acts.

From the sentence above Mayor Englemann want to prepare Hansel and Gretel to ready for hunting other witches in his village after finishing debate with sheriff Berringer. The type of speech act of the sentence is Request, because Mayor Englemann Invite Hansel and Gretel to get them ready

# 4. Suggestion

Is a form that means that what is conveyed by the speaker can be carried out by the speech partner. You better fast before our mayor's witch hunters rob this town blind

From the sentence above Sheriff Berringer tells everyone to act faster to hunt down the witches so they don't lose to Hansel and Gretel. The type of speech of the sentence is suggestion, because Sheriff Berringer trying go give advice to everyone who want hunt down the witches.
